

FOREIGNER REGULATIONS

1. Foreigner Regulations

a. Visa Regulations for Foreign Nationals Attending the GlassTech and Fenestration Asia 2025 Exhibition Venue:

- C8A Visa

The C8A visa is intended for foreign nationals participating in non-commercial sports activities, such as sports events held by invitation from the Government of Indonesia, international-level sports competitions, or sports events organized by international sports organizations, in the capacity of an athlete.

- C8B Visa

The C8B visa is applicable for foreign nationals involved in non-commercial sports activities, such as sports events held by invitation from the Government of Indonesia, international-level sports competitions, or sports events organized by international sports organizations, in the capacity of an official (e.g., coach, crew, or manager).

- C10 Visa

The C10 visa is designated for foreign nationals participating in meetings, incentives, conventions, exhibitions (MICE), or similar events, in the role of a speaker, presenter, or influential figure. This visa is strictly for individuals serving as speakers at events and does not permit the holder to be stationed at or operate a booth.

- C11 Business Visa (Exhibition)

The C11 visa is suitable for foreign nationals attending meetings, incentives, conventions, and exhibitions (MICE) for the purpose of marketing goods or services as an exhibitor. This visa allows direct marketing activities at exhibition booths. However, it does not permit the visa holder to act as a speaker or presenter during the exhibition.

- b. All visa applicants as mentioned above are required to have a guarantor/sponsor in Indonesia.
- c. **Participants must inform their colleagues or foreign invitees who will be attending the exhibition venue about the applicable visa types to ensure the smooth running of the exhibition.**
- d. **In addition to the aforementioned visas, foreign nationals are also required to complete a declaration form via the All Indonesia application (available on the Play Store or App Store), or by visiting the website allindonesia.imigrasi.go.id, in order to obtain clearance from immigration.**
- e. **The organizer shall not be held responsible for any negligence in the processing of foreign nationals' travel or immigration documents.**

2. Visa Submission by Guarantor/Sponsor

- a. The sponsor must create or use a registered account at evisa.imigrasi.go.id
The guarantor or sponsor submits the visa application by attaching the required supporting documents.
- b. Visa fees must be paid according to the issued billing code.
- c. The application will be verified by the Directorate General of Immigration.
- d. If approved, the visa will be issued and sent electronically.

3. Required Documents

- a. Letter of application and statement letter from the guarantor/sponsor.
- b. Applicant's passport (with a minimum validity of 6 months, or 12 months for non-national travel documents).
- c. Proof of sufficient funds for the duration of stay in Indonesia (bank statement for the last 3 months under the name of the guarantor or sponsor).
- d. Recent color passport photo (taken within the last 12 months).
- e. Letter of confirmation or invitation from the event/exhibition organizer.

- f. For holders of special travel documents (non-national passports), it is mandatory to attach a re-entry permit to the country of origin, as well as a return ticket or a ticket to a third country.

4. **Visa Approval Procedure**

Here are the steps for Visa Approval :

- Document requirements review
- Payment verification
- Profile creation and verification
- Approval process
- Visa issuance (in electronic format)
